Plaintiffs 22 Zone Sports, LLC, and Claire Barbis were represented by Douglas Thornton, Esq., and Defendant 23 Ben Rodriguez was represented by Stephen Pass, Esq. 24 The Court informed the parties that because outstanding threshold legal issues remained 25 unresolved before trial, the Court would sua sponte order briefing on the dispositive issue of 26 Plaintiff Zone Sports, LLC's standing to pursue a Fourth Amendment violation against Defendant 27 Ben Rodriguez. 28

By no later than July 27, 2016, the parties are ORDERED to file a supplemental Joint Pretrial Statement pursuant to Local Rule 281(a)(2) addressing the changes to Plaintiffs' claims, if any, resulting from the Court's order on Plaintiff Zone Sports, LLC's standing to pursue a Fourth Amendment claim. The parties are further ORDERED to submit a digital copy of their pretrial Microsoft statement in Word format directly chambers email to by at SKOorders@caed.uscourts.gov. The attention of counsel is directed to Rules 281 and 282 of the Local Rules of the Eastern District of California, as to the obligations of counsel in preparing for the pre-trial conference.
