ORDER GRANTING APPLICATION TO
PROCEED IN FORMA PAUPERIS
(ECF NOS. 28 & 32)

and

ORDER DIRECTING PAYMENT
OF INMATE FILING FEE BY CALIFORNIA
DEPARTMENT OF CORRECTIONS

18 Plaintiff is a state prisoner proceeding *pro se* in this civil rights action pursuant to 42
19 U.S.C. § 1983, and has requested leave to proceed *in forma pauperis* pursuant to 28 U.S.C.
20 § 1915. Plaintiff has made the showing required by § 1915(a) and accordingly, the application to
21 proceed in forma pauperis will be granted. Plaintiff is obligated to pay the statutory filing fee of
22 \$350.00 for this action. 28 U.S.C. § 1915(b)(1). Plaintiff is obligated to make monthly payments
23 in the amount of twenty percent of the preceding month's income credited to Plaintiff's trust
24 account. The California Department of Corrections is required to send to the Clerk of the Court
25 payments from Plaintiff's account each time the amount in the account exceeds \$10.00, until the
26 statutory filing fee is paid in full. 28 U.S.C. § 1915(b)(2).

27 In accordance with the above and good cause appearing therefore, IT IS HEREBY
28 ORDERED that:

1 1. Plaintiff's application to proceed in forma pauperis is GRANTED;

2 **2. The Director of the California Department of Corrections or his designee**
3 **shall collect payments from Plaintiff's prison trust account in an amount equal to**
4 **twenty per cent (20%) of the preceding month's income credited to the prisoner's**
5 **trust account and shall forward those payments to the Clerk of the Court each time**
6 **the amount in the account exceeds \$10.00, in accordance with 28 U.S.C. § 1915(b)(2),**
7 **until a total of \$350.00 has been collected and forwarded to the Clerk of the Court.**
8 **The payments shall be clearly identified by the name and number assigned to this**
9 **action.**

10 3. The Clerk of the Court is directed to serve a copy of this order and a copy of
11 Plaintiff's in forma pauperis application on the Director of the California Department of
12 Corrections, via the court's electronic case filing system (CM/ECF).

13 4. The Clerk of the Court is directed to serve a copy of this order on the Financial
14 Department, U.S. District Court, Eastern District of California, Sacramento Division.

15 5. Within sixty (60) days of the date of service of this order, Plaintiff shall submit a
16 certified copy of his prison trust account statement for the six-month period immediately
17 preceding the filing of the complaint, if Plaintiff has not already done so.

18 IT IS SO ORDERED.
