1. This Court ordered that an appraiser be hired and provide an appraisal report for the above-captioned defendant vehicles.

2. Upon obtaining the results of the appraisal, the United States and counsel for Claimants met and conferred regarding stipulation for the sale of all of the defendant vehicles.

3. The Stipulation is as follows:

a. The following vehicles will be sold with the following minimum sale prices:

1962 Impala Convertible \$21,000.00

1965 Mustang (white) \$ 6,000.00

1965 Mustang (black) \$ 6,200.00

1969 Chevy Pick up \$ 13,000.00

1972 Olds 442 Convertible \$ 31,000.00

1 b. The remaining vehicles will be sold with no minimum sale price.

2 c. Upon conclusion of the last vehicle sold, the United States shall
3 inform Claimants' counsel of the sale price, and the sale proceeds, less storage/
4 maintenance/transportation costs, shall be held an in interest-bearing account, as
5 customarily held in an asset forfeiture case.
