IT IS HEREBY STIPULATED by and between defendant California Water Service Company (“Cal Water”) and plaintiffs Viola Coppola, Gary Coppola, and the Trust of Anthony M. Coppola (“Plaintiffs”) that the deadline for Cal Water to respond to Plaintiffs’ Second Amended Complaint (“SAC”) shall be extended by a period of twenty-eight (28) days. Cal Water was served with the SAC on July 9, 2012, and the original deadline for Cal Water’s responsive pleading was twenty-one (21) days later, July 30, 2012.
