16 This case is set for a Settlement Conference before Magistrate Judge Sheila K. Oberto on
17 June 6, 2013, at 10:00 a.m. at the U. S. District Court, 2500 Tulare Street, Fresno, California,
18 93721.

19 Consideration of settlement is a serious matter that requires thorough preparation prior to
20 the settlement conference. Accordingly, IT IS HEREBY ORDERED that:

21 **1. Pre-settlement Conference Exchange of Demand and Offer**

22 A settlement conference is more likely to be productive if, before the conference, the
23 parties exchange written settlement proposals. Accordingly, at least fifteen (15) days prior to the
24 settlement conference, plaintiff's counsel shall submit a written itemization of damages and
25 settlement demand to each defense counsel with a brief summary of the legal and factual basis
26 supporting the demand. No later than ten (10) days prior to the settlement conference, each
defense counsel shall submit a written offer to plaintiff's counsel with a brief summary of the
legal and factual basis supporting the offer.

2. Submission and Content of Confidential Settlement Conference Statements

The parties are to send Confidential Settlement Conference Statements (Settlement
Statement) to the following email address: SKOorders@caed.uscourts.gov, to arrive no later than
five (5) business days before the conference. Additionally, each party shall file a Notice of

1 Submission of Confidential Settlement Conference Statement (See L.R. 270 (d)).

2 If the Settlement Conference is continued for any reason, each party must submit a new
3 Settlement Statement that is complete in itself, without reference to any prior Settlement
4 Statements.

5 Settlement Statements must be typed and double spaced. Each Settlement Statement
6 *shall include the following:*

- 7 a. A brief summary of the core facts, allegations, and defenses.
- 8 b. A summary of the proceedings to date.
- 9 c. An estimate of the cost and time to be expended for further discovery,
10 pretrial, and trial.
- 11 d. The nature of the relief sought.
- 12 e. An outline of past settlement efforts including information regarding the
13 "Pre-settlement Conference Exchange of Demand and Offer" required
14 above (including the itemization of damages), and a history of past
15 settlement discussions, offers, and demands.
- 16 f. A statement of each party's expectations and goals for the Settlement
17 Conference.

18 **3. Attendance of Trial Counsel and Parties Required**

19 *The attorneys who will try the case and parties with full and complete settlement*
20 *authority are required to personally attend the conference.¹ An insured party shall appear by a*
21 *representative of the insurer who is authorized to negotiate, and who has authority to settle the*
22 *matter up to the limits of the opposing parties' existing settlement demand. An uninsured*

23 ¹Insurance carriers, business organizations, and governmental bodies or agencies whose
24 settlement agreements are subject to approval by legislative bodies, executive committees, boards
25 of directors or the like shall be represented by a person or persons who occupy high executive
26 positions in the party organization and who will be directly involved in the process of approval of
any settlement offers or agreements. To the extent possible, the representative shall have the
authority, if he or she deems it appropriate, to settle the action on terms consistent with the
opposing party's most recent demand.

1 corporate party shall appear by a representative authorized to negotiate, and who has *authority to*
2 *settle the matter up to the amount of the opposing parties' existing settlement demand or offer.*

3 It is difficult for a party who is not present to appreciate the process and the reasons that may
4 justify a change in one's perspective toward settlement. Accordingly, having a client with
5 authority available by telephone is *not* an acceptable alternative, except under the most
6 extenuating circumstances.²

7 The Court expects both the lawyers and the party representatives to be fully prepared to
8 participate. The Court encourages all parties to keep an open mind in order to reassess their
9 previous positions and to discover creative means for resolving the dispute.

10 **4. Issues to Be Discussed**

11 The parties *shall* be prepared to discuss the following at the settlement conference:

- 12 a. Goals in the litigation and problems they would like to address in the
13 settlement conference and understanding of the opposing side's goals.
- 14 b. The issues (in and outside the lawsuit) that need to be resolved.
- 15 c. The strengths and weaknesses of their case.
- 16 d. Their understanding of the opposing side's view of the case.
- 17 e. Their points of agreement and disagreement (factual and legal).
- 18 f. Any financial, emotional, and/or legal impediments to settlement.
- 19 g. Whether settlement or further litigation better enables the accomplishment
20 of their respective goals.
- 21 h. Any possibilities for a creative resolution of the dispute.

22 **5. Statements Inadmissible**

23 The parties are expected to address each other with courtesy and respect, and are
24 encouraged to be frank and open in their discussions. Statements made by any party during the

25 ² Out of town or out of state travel and the purchase of an airplane ticket are not
26 extenuating circumstances.

1 settlement conference are not to be used in discovery and will not be admissible at trial.

IT IS SO ORDERED.
