9 inmate and is ordered to provide the new custodian with a copy of this writ.

10 **WRIT OF HABEAS CORPUS AD TESTIFICANDUM**

11 **To: Warden, CSATF, P.O. Box 7100, Corcoran, California 93212:**

12 **WE COMMAND** you to produce the inmate named above to participate in trial  
13 before Judge Seng at the time and place above, until completion of the trial or as  
14 ordered by the Court; and thereafter to return the inmate to the above institution, or other  
15 appropriate facility at the discretion of the California Department of Corrections and  
16 Rehabilitation. This inmate's legal property, relevant to the above entitled case, shall  
17 accompany the inmate.

18 **FURTHER**, you have been ordered to notify the Court of any change in custody of  
19 the inmate and have been ordered to provide the new custodian with a copy of this writ.
