Plaintiff Robin Dasenbrook (“Plaintiff”) is a state prisoner proceeding pro se and in forma pauperis in this civil rights action pursuant to 28 U.S.C. § 1983. This action is proceeding against Defendants Enenmoh, Page, Perez, and blonde Doe 1 for claims of negligence and deliberate indifference to a serious medical need in violation of the Eighth Amendment.

On April 24, 2015, the Court issued an order authorizing the issuance of a subpoena duces tecum. Fed. R. Civ. P. 4, 45; 28 U.S.C. § 1915(d). The requisite notice having been issued pursuant to Federal Rule of Civil Procedure 45(a)(4)<sup>1</sup>, it is HEREBY ORDERED that:

<sup>1</sup> The Court notes that on May 11, 2015, the CSATF Litigation Coordinator responded to the Court’s notice by submitting an affidavit and copy of the log book entry for January 2, 2010. However, the Subpoena Duces Tecum was not issued; only a copy was noticed to Defendants pursuant to Fed. R. Civ. P. 4, 45. Therefore, the Clerk of Court will be directed to return Defendants submission.

1           1.       The Clerk of the Court is directed to return Defendants' submission of May 11, 2015,  
2 to Defendants.

3           2.       The Clerk of the Court shall forward the following documents to the United States  
4 Marshal (USM):

5               a.       One (1) completed and issued subpoena duces tecum to be served on:

6                               Stu Sherman, Warden  
7                               CSATF, Corcoran State Prison  
8                               P.O. Box 5242  
9                               Corcoran, CA 93212

10              b.       One (1) completed USM-285 form; and

11              c.       Two (2) copies of this order, one to accompany the subpoena and one for the  
12 USM;

13           3.       Within seven (7) calendar days from the date of this order, the USM is DIRECTED to  
14 serve the subpoena in accordance with the provisions of Rule 45 of the Federal Rules of Civil  
15 Procedure;

16           4.       The USM SHALL effect personal service of the subpoena duces tecum, along with a  
17 copy of this order, upon the individual/entity named in the subpoena pursuant to Rule 45 of the  
18 Federal Rules of Civil Procedure and 28 U.S.C. § 566(c); and

19           5.       Within ten (10) days after personal service is effected, the USM SHALL file the return  
20 of service, along with the costs subsequently incurred in effecting service, and said costs shall be  
21 enumerated on the USM-285 form.
