24 The undersigned parties hereby enter into the following stipulation regarding plaintiff

1           1.       Defendants Hanford Police Officer Steven Schmitz and the City of Hanford will

7           3.       Plaintiff will withdraw his pending motion, currently scheduled to be heard on  
8 May 22, 2013, before the Hon. Stanley A. Boone.
