20 Paul Montanez ("Plaintiff"), an inmate at the Los Angeles County Jail, is proceeding  
21 with counsel in this civil rights action pursuant to 42 U.S.C. § 1983. This case is scheduled for  
22 a Settlement Conference before Magistrate Judge Erica P. Grosjean on April 18, 2016 at 10:30  
23 a.m.

24 On March 22, 2016, Plaintiff filed an ex parte application to set a status conference in  
25 this case to discuss issues with arranging for Plaintiff's transportation to the Settlement  
26 Conference, filing a motion for leave to amend the Complaint, and re-opening fact discovery.  
27 Plaintiff's counsel has spoken of these issues with defense counsel, and the parties are available

1 Plaintiff has shown good cause for the Court to schedule a telephonic status conference  
2 before the Court. Therefore, Plaintiff's application shall be granted.

4 This case is now scheduled for a telephonic status conference before Magistrate Judge  
5 Erica P. Grosjean on Monday, **March 28, 2016 at 10:00 a.m.** in Courtroom 10. The parties  
6 shall be prepared to informally discuss Plaintiff's transportation to the Settlement Conference,  
7 Plaintiff's proposed motion for leave to amend, and whether discovery should be re-opened.  
8 Counsel for the parties shall coordinate a one-line conference call and initiate the status  
9 conference at chambers phone number **(550) 499-5960**.

10 Based on the foregoing, IT IS HEREBY ORDERED that:

11 1. Plaintiff's application to schedule a status conference, filed on March 22, 2016,  
12 is GRANTED; and

13 2. This case is scheduled for a telephonic status conference on Monday, **March 28,**  
14 **2016 at 10:00 a.m.** in Courtroom 10 before the Honorable Magistrate Judge Erica P. Grojean.
