18) **ORDER CONFIRMING
ARBITRATION AWARDS**

) **COURT LANGUAGE ADDED**

19 The petition of PAINTERS DISTRICT COUNCIL 16, LOCAL UNION 294,
20 (hereinafter "Petitioner") for an Order Confirming Arbitration Award, and the
21 Motion of COLOR NEW CO. and LOUIE ANDREW LOIZU d/b/a COLOR NEW
22 CO., (hereinafter "Respondents") was taken under submission by this Court. On
23 proof being made to the satisfaction of the Court, and good cause appearing
24 therefore, especially given denial to vacate the arbitration award:

25 IT IS HEREBY ORDERED that the Arbitration Awards of April 11, 2013 and
26 June 10, 2013, incorporated herein, are confirmed in their entirety and made an order
27 of this Court. Respondents are ordered to comply with said Awards in all respects,

1 including, but not limited to, that Respondents shall pay to Petitioner the sum of
2 \$29,672.11 in wages and benefits and \$2,500.00 for the costs of arbitration.

3 Petitioner further seeks an award of \$10,735 for attorney fees and \$3,070.41
4 in costs to address Respondents' refusal to comply with the Arbitration Awards.
5 This Court has reviewed Petitioner's supporting documentation and finds appropriate
6 under the circumstances an attorney fees award of \$7,000 and costs of \$534.48. *See*
7 *Sheet Metal Workers' Int'l Local Union No. 35 v. Madison Industries, Inc. of Arizon*,
8 84 F.3d 1186, 1192 (9th Cir. 1996). As such, Respondents owe Petitioner a total of
9 \$39,706.59.
