21 22	On May 13, 2013, the Magistrate Judge filed a Findings and Recommendations which was		
22	served on the parties and which contained notice to the parties that any objection to the Findings and		
23 24	Recommendations was to be filed within fourteen days. ECF No. 15. No party filed a timely		
25	Objection to the Findings and Recommendations.		
26	In accordance with the provisions of 28 U.S.C. § $636(b)(1)$ , this Court has conducted a <i>de novo</i> review of this case. Having carefully reviewed the entire file, the Court finds the Findings and

28	Recommendations to be supported by the record and by proper analysis.

1	Accordingly, IT IS HEREBY ORDERED that:	
2	1.	The Findings and Recommendations, filed May 13, 2013, is adopted in full;
3	2.	This action proceeds against Defendants Igbinosa, Trimble, Jardini, and Green for
4		deliberate indifference to a serious medical need in violation of the Eighth
5		Amendment;
6	3.	Defendants Allen and Yates are dismissed from this action with prejudice for failure
7		to a claim;
8	4.	Defendants' Motion for extension of time to file a responsive pleading, filed June 5,
9		2013 (Doc. No. 17), is granted; and
10	5.	Defendants are granted up to and including July 2, 2013 by which to file their
11		responsive pleading.
12	IT IS SO ORDERED.
