19	On July 5, 2013, the Court issued an order discharging the Court's May 28, 2013, Order to	
20	Show Cause and requiring Plaintiffs Nadia Roberts, et al. ("Plaintiffs") to file Notices of Dismissa	
21	for the non-viable Defendants identified by Plaintiffs and file either Proofs of Service or Notices	
22	of Dismissal as to Defendants Hansruedi Schumacher ("Schumacher") and Matthias Rickenbach	
23	("Rickenbach"). (Doc. 50.)	
24	On August 2, 2013, Plaintiffs filed a Request for Dismissal of the non-viable Defendants	
25	which was approved by the Court on August 5, 2013. (Doc. 51, 52.) Plaintiffs, however, have no	
26	yet filed Proofs of Service or Notices of Dismissal as to Defendants Schumacher and Rickenbach.	
27	Accordingly, within ten (10) days of the date of this order, Plaintiffs shall file either Proofs	
28	of Service or Notices of Dismissal as to D	refendants Schumacher and Rickenbach. As Plaintiffs

1	have been previously informed by this Court, Plaintiffs' failure to comply with the Court's order	
2	may result in dismissal of these Defendants pursuant to Rule 4(m) of the Federal Rules of Civil	
3	Procedure, which provides that "'[i]f a defendant is not served within 120 days after the complaint	
4	is filed, the court – on motion or on its own after notice to the plaintiff – must dismiss the action	
5	without prejudice against that defendant or order that service be made within a specified time."	
6	(Doc. 48, 3:13-16 (citing Fed. R. Civ. P. 4(m).)	
7	Additionally, the Court SETS a scheduling conference in this action for November 26,	
8	2013, at 9:45 a.m., in Courtroom 7 before Magistrate Judge Sheila K. Oberto.	
9	Accordingly, IT IS HEREBY ORDERED that:	
10	1. Within ten (10) days of the date of this order, Plaintiffs shall file Proofs of Service	
11	or Notices of Dismissal for Defendants Schumacher and Rickenbach; and	
12	2. A Scheduling Conference is set for November 26, 2013, at 9:45 a.m., in	
13	Courtroom 7 before Magistrate Judge Sheila K. Oberto.
