Pursuant to Section VI.(B) of the Scheduling Order in the above captioned case, Plaintiff and Counterdefendant Fresno Unified School District (“Plaintiff”) and Defendants and Counterclaimants K.U. and A.D.U. (“Defendants”) (Plaintiffs and Defendants shall be collectively referred to herein as the “Parties”) are to lodge the Administrative Record in OAH Case No. 2012010705 (hereafter the "Administrative Record") with the Court on April 15, 2013 and any supplement to the Administrative Record is to be lodged with this Court by May 15, 2013.

2. On February 13, 2013, F. Richard Ruderman of Ruderman & Knox, LLP, filed a Motion to Withdraw As Counsel for Defendants in the above-captioned matter (hereafter the "Ruderman Motion to Withdraw").

3. On February 22, 2013, Plaintiff filed its Statement of Non-Opposition to the Ruderman Motion to Withdraw.

4. On April 5, 2013, the Court continued the hearing on the Ruderman Motion to Withdraw to May 3, 2013.
