**STIPULATION AND ORDER RE
FILING OF DISPOSITIVE

22 Plaintiff California Consortium for Agricultural Export, LLC (“**CCA**”) and Defendant Zhonglin Co., LLC (“**Zhonglin**”), by and through their respective counsel of record, hereby STIPULATE AND AGREE as follows:

23 1. The parties filed a Joint Notice of Settlement on September 26, 2014,
