28	2. The party's assessment of what factors, if any, will prevent settlement of this	

1	matter prior to trial; and		
2	3. Any additional information the Court may find useful in determining whether to		
3	set this matter for a settlement conference.		
4	Should the Court determine this action to be appropriate for referral to the		
5	Prisoner Settlement Program, the Court will set this matter for a settlement conference		
6	before a magistrate judge or district judge.		
7	Accordingly, IT IS HEREBY ORDERED that:		
8	1. Within fifteen days from the date of this Order, the parties shall submit		
9	confidential statements as set forth above; and
