12 3. The hearing on Defendants’ Motion to Dismiss Pursuant to Rule 12(b)(6) [Docket #
13 18], shall be continued from July 8, 2013 until August 5, 2013, 1:30 p.m., before the Honorable
14 Judge Anthony W. Ishii;

15 4. The hearing on Plaintiffs’ Motion to Remand Action to State Court and Motion for
16 Award of Attorney’s Fees and Costs [Docket #20], shall be continued from July 12, 2013 (before
17 Magistrate Judge Michael J. Seng) until August 5, 2013, 1:30 p.m., before the Honorable Judge
18 Anthony W. Ishii;

19 5. The briefing schedule for the aforementioned motions shall be set as follows:

20 a. Defendants’ Opposition to Plaintiffs’ aforementioned Motion to Remand
21 shall be due on July 22, 2013;

22 b. Defendants’ Reply in support of the aforementioned Motion to Strike shall be
23 due on July 29, 2013;

24 c. Defendants’ Reply in support of the aforementioned Motion to Dismiss
25 Pursuant to Rule 12(b)(6) shall be due on July 29, 2013; and
