**ORDER REGARDING CLERK'S
ISSUANCE OF WARRANT FOR ARREST
OF ARTICLES *IN REM***

22 WHEREAS, a Verified Complaint for Forfeiture *In Rem* has been filed on July 11,
23 2013, in the United States District Court for the Eastern District of California, alleging
24 that defendants approximately \$700.00 in U.S. Currency (hereafter "defendant currency"),
25 approximately \$10,474.21 seized from Wells Fargo Account Number 7064503779, and
26 approximately \$3,236.05 seized from Bank of the West Account Number 028561662
27 (hereafter collectively "defendant funds") are subject to forfeiture to the United States

1 pursuant to 21 U.S.C. § 881(a)(6), for one or more violations of 21 U.S.C. §§ 841 *et seq.*;

2 And, the Court being satisfied that, based on the Verified Complaint for Forfeiture *In*
3 *Rem* and the affidavit of Drug Enforcement Administration, Task Force Officer Chad
4 Rhyman, there is probable cause to believe that the defendant currency and defendant
5 funds so described constitute property that is subject to forfeiture for such violation(s), and
6 that grounds for the issuance of a Warrant for Arrest of Articles *In Rem* exist, pursuant to
7 Rule G(3)(b)(i) of the Supplemental Rules for Admiralty or Maritime Claims and Asset
8 Forfeiture Actions;

10 IT IS HEREBY ORDERED that the Clerk for the United States District Court,
11 Eastern District of California, shall issue a Warrant for Arrest of Articles *In Rem* for the
12 defendant currency and defendant funds.
