 20 paid by the Defendant, pursuant to the Equal Access to Justice Act (EAJA), 28 U.S.C.
 21 § 2412(d), subject to any offset as described in *Astrue v. Ratliff*, 130 S.Ct. 2521 (2010).

22 The parties agree that an award of attorney's fees and expenses in the amount of \$8,000.00,
 23 shall be awarded to Plaintiff as a settlement amount.

24 If it is determined that Plaintiff's EAJA fees and expenses are not subject to any offset
 25 allowed under the Department of the Treasury's Offset Program, then the check for EAJA fees
