1 ORDERED, ADJUDGED, AND DECREED:

2 1. The Court adopts the Magistrate Judge's December 11, 2013 Findings and
3 Recommendations Recommending the Grant of Plaintiff's Ex Parte Application for Default
4 Judgment in full.

5 2. Jeffrey Owen Gilbert, Ethan Joseph Milhous, and Mitch M. Milhous are held in
6 default.

7 3. A judgment by default is hereby entered against any right, title, or interest in the
8 defendant approximately \$15,408.00 in U.S. Currency, and all other potential claimants
9 who have not filed claims in this action.

10 4. A final judgment is hereby entered forfeiting all right, title, and interest in the
11 defendant approximately \$15,408.00 in U.S. Currency, including all right, title, and interest
12 of Jeffrey Owen Gilbert, Ethan Joseph Milhous, and Mitch M. Milhous; and vesting all
13 right, title, and interest in the defendant approximately \$15,408.00 in U.S. Currency, to be
14 disposed of according to law.

15 5. All parties shall bear their own costs and attorney's fees.
