The parties, through their undersigned counsel hereby stipulate as follows:

WHEREAS the current expert designation deadline is July 18, 2014, and

STIPULATION AND ORDER RE: MENTAL HEALTH RECORDS

1 WHEREAS the current overall expert discovery completion date is September 19, 2014,
2 and

3 WHEREAS non-expert discovery is currently at a stage where the designation of experts
4 would be premature, in that the experts would have to review and consider the discovery that
5 remains pending in order to produce reports that comply with FRCP 26(a)(2)(B), and

7 WHEREAS the parties further believe that the ends of justice would be better served if
8 the expert and non-expert discovery completion deadlines were one and the same, and

10 THE PARTIES HEREBY STIPULATE to extend the expert designation date to August

13 discovery is currently scheduled to be completed. All other deadlines shall remain in effect.
