21 This matter is before the Court on plaintiff United States' Ex Parte Motion for
22 Default Judgment filed March 19, 2014. The Magistrate Judge has recommended that the
23 United States' motion for default judgment be granted. The time for objecting to the
24 Findings and Recommendations of the Magistrate has passed and no timely objections have
25 been filed. An Order Adopting the Magistrate Judge's Findings and Recommendations was
26 filed on May 28, 2014. Based on the Magistrate Judge's Findings and Recommendations on
27 Plaintiff's Ex Parte Application for Default Judgment, the Order Adopting the Magistrate
28 Judge's Findings and Recommendations, and the files and records of the Court, it is

1 ORDERED, ADJUDGED, AND DECREED:

2 1. The Court adopts the Magistrate Judge's April 24, 2014 Findings and
3 Recommendations in full.

4 2. Gabriel Lorenzo Gonzales and Mark Dustin Levi Huggins are held in default.

5 3. A judgment by default is hereby entered against any right, title, or interest in the
6 defendants approximately \$7,000.00 in U.S. currency, approximately \$8,950.00 in U.S.
7 currency, and approximately \$10,010.00 in U.S. currency (hereafter "defendant currency"),
8 and all potential claimants who have not filed claims in this action.

9 4. A final judgment is hereby entered forfeiting all right, title, and interest in the
10 defendant currency to the United States of America, to be disposed of according to law,
11 including all right, title, and interests of Gabriel Lorenzo Gonzales and Mark Dustin Levi
12 Huggins.

13 5. All parties shall bear their own costs and attorney's fees.
