**STIPULATION TO VOLUNTARY  
 REMAND PURSUANT TO SENTENCE  
 FOUR OF 42 U.S.C. § 405(g) AND TO  
 ENTRY OF JUDGMENT;  
 ORDER THEREON**

21 THE PARTIES HEREBY STIPULATE, through their undersigned attorneys and with the  
 22 approval of the Court, that Defendant has agreed to a voluntary remand of this case pursuant to sentence  
 23 four of 42 U.S.C. § 405(g). The purpose of the remand is to offer Plaintiff a new hearing and decision.

24 Upon remand, the Office of Disability Adjudication and Review will remand this case to an  
 25 Administrative Law Judge (ALJ) and direct him or her to further evaluate Plaintiff’s residual functional  
 26 capacity. If the ALJ finds Plaintiff unable to perform any of her past relevant jobs, the ALJ will obtain  
 27 vocational expert testimony regarding whether there is other work that Plaintiff could perform. Finally,  
 28 the ALJ will take any other actions he or she deems necessary to make a decision.

1 As noted, this stipulation constitutes a remand under the *fourth sentence* of Section 205(g) of the  
2 Social Security Act. 42 U.S.C. § 405(g).
