18	After a pattern of non-responsive conduct by Defendants Dolarian Capital, Inc, Ara	
19	Dolarian, and defense counsel Myron Smith, the Magistrate Judge issued an Order to Show Cause	
20	why sanctions should not be imposed, including the striking of all pleadings filed by the	
21	Defendants. (ECF No. 36.) Defendants and defense counsel failed to respond to the Order to	
22	Show Cause and did not appear at the hearing. (ECF Nos. 38, 39.) On July 20, 2015, the	
23	Magistrate Judge issued Findings and Recommendations recommending the striking of	
24	Defendants' responsive pleadings and granting of entry of default. (ECF No. 39.) The Findings	
25	and Recommendations were served on Defendants with instructions that any objections must be	
26	filed within fourteen days. No objections have been filed.	
27	In accordance with the provisions of 28 U.S.C. § 636(b)(1)(C), this Court has conducted a	
28	de novo review of the case. Having carefully reviewed the entire file, the Court finds that the

1	Findings and Recommendations are supported by the record and proper analysis. Accordingly, IT	
2	IS HEREBY ORDERED that:	
3	1. The Findings and Recommendations dated July 20, 2015 (ECF No. 39), are	
4	ADOPTED IN FULL;	
5	2. Defendants Dolarian Capital, Inc. and Ara G. Dolarian's responsive pleadings	
6	(ECF Nos. 16, 17) shall be STRICKEN;	
7	3. The Clerk of the Court is DIRECTED to enter default against Defendants Dolarian	
8	Capital, Inc. and Ara G. Dolarian; and,	
9	4. Plaintiff is DIRECTED to file a motion for default judgment pursuant to Federal	
10	Rule of Civil Procedure 55 within sixty days after the Clerk of the Court has	
11	entered default against Defendants.
