18 IT IS HEREBY STIPULATED, by and between the parties, through their respective  
19 counsel of record, that this action be remanded to the Commissioner of Social Security for further  
20 administrative action pursuant to section 205(g) of the Social Security Act, as amended, 42  
21 U.S.C. section 405(g), sentence four. Upon remand from the Court, the Appeals Council will  
22 remand the case to an Administrative Law Judge (ALJ) for a new hearing and a new decision.  
23 The Appeals Council will instruct the ALJ to update the medical record; obtain supplemental  
24 vocational expert testimony; provide Tod E. Kneeland the opportunity for a new hearing; and  
25 issue a new decision.

26 The parties further request that the Clerk of the Court be directed to enter a final judgment  
27 in favor of Plaintiff, and against Defendant, Commissioner of Social Security, reversing the final
