17	Plaintiff Merrick Jose Moore ("Plaint	iff") is a state prisoner proceeding pro se and in	
18	forma pauperis in this civil rights action purs	uant to 42 U.S.C. § 1983. This action proceeds on	
19	Plaintiff's Eighth Amendment claims for exc	essive force against Defendants Meier, Casas,	
20	Childress, and Adams, and for failure to inter	evene against Defendants Ford and Thornburg. This	
21	matter was referred to a United States Magist	trate Judge pursuant to 28 U.S.C. § 636(b)(1)(B) and	
22	Local Rule 302.		
23	On March 12, 2018, a non-party, Carr	mi Johnson, filed a declaration in this matter. (ECF	
24	No. 68.) Ms. Johnson identifies herself in the declaration as the cousin of Plaintiff. Attached are		
25	various exhibits, including letters purportedly	v sent to Ms. Johnson from Plaintiff, emails, and	
26	envelopes.		
27	Both the Federal Rules of Civil Proce	dure and this Court's Local Rules require that all	
28	filed pleadings, motions, and papers be signe	d by at least one attorney of record or by the party 1	

1	personally if the party is represented. Fed. R. Civ. P. 11(a); Local Rule 131(b).		
2	The declaration does not state any particular motion or pending request in this action to		
3	which it relates. Further, this document is not signed by an attorney of record or by a party, and		
4	as such it will be stricken from the record. Plaintiff is advised that to the extent he would submit		
5	evidence in support of a pending request, that evidence should be attached to a proper filing,		
6	signed by Plaintiff, that explains what the evidence is and for what purpose it should be		
7	considered.		
8	Furthermore, at this time, the only pending matter is Plaintiff's motion for an extension of		
9	time regarding the submission of his discovery responses. Defendants' opposition or statement of		
10	non-opposition to that request is currently due on or before March 19, 2018.		
11	Accordingly, it is HEREBY ORDERED that the Declaration of Carmi Johnson, filed		
12	March 12, 2018, (ECF No. 68), is STRICKEN from the record.
