The 18 Court dismissed this case on May 23, 2014, for failure to state a claim. Plaintiff was subsequently 19 released from custody and on that ground, the appellate court vacated the dismissal of Plaintiff's 20 Heck-barred due process claim and remanded it for further consideration. Nonnette v. Small, 316 21 F.3d 872, 875-76 (9th Cir. 2002) (Heck habeas bar does not preclude section 1983 action once 22 prisoner is released from custody because habeas relief is no longer available). Mandate was 23

issued on April 14, 2015, and the Court has reviewed the record. Plaintiff has not notified the Court of any change in his address and his address of record with the district court remains Mountain Home Conservation Center. Plaintiff has a duty to keep the Court apprised of his current address, and he is required to file a notice of change of address within thirty days. Local Rule 183(b).
