17	Plaintiffs, state prisoners proceeding through counsel, have filed a civil rights action	
18	pursuant to 42 U.S.C. § 1983. Plaintiffs have paid the filing fee for this action.	
19	The federal venue statute provides that a civil action	
20	may be brought in (1) a judicial district in which any defendant resides, if all defendants are residents of the State in which the	
21	district is located, (2) a judicial district in which a substantial part of the events or omissions giving rise to the claim occurred, or a	
22	substantial part of property that is the subject of the action is situated, or (3) if there is no district in which an action may	
23	otherwise be brought as provided in this action, any judicial district in which any defendant is subject to the court's personal	
24	jurisdiction with respect to such action.	
25	28 U.S.C. § 1391(b).	
26	Upon reviewing the complaint, the court finds that venue is more appropriate over this	
27	civil action in the Fresno Division of this court. Plaintiffs' complaint concerns their allegedly	
28	unconstitutional transfer to, and acceptance for	or imprisonment at, Pleasant Valley State Prison, 1

1	Avenal State Prison, and C.C.I. Tehachapi, where they contracted Coccidioidomycosis or "Valley	
2	Fever." Witnesses and the evidence necessary for the resolution of plaintiffs' claims would	
3	appear to be more readily available within the boundaries of the Fresno Division of this court	
4	where all of the institutions at issue are located. Therefore, in the interest of justice, the court will	
5	transfer this action to the Fresno Division of the court. See 28 U.S.C. § 1406(a).	
6	Good cause appearing, IT IS HEREBY ORDERED that:	
7	1. This action is transferred to the United States District Court for the Eastern District of	
8	California sitting in Fresno; and	
9	2. All future filings shall reference the new Fresno case number assigned and shall be	
10	filed at:
