18 **I. STIPULATION**

19 JAN RICHMOND (“Plaintiff”) and MISSION BANK (“Defendant”) hereby stipulate to  
20 vacate the Settlement Conference currently set for December 16, 2014 and reset the Settlement  
21 Conference at the request of the Parties pursuant to the Court’s July 9, 2014 Scheduling Order  
22 based upon the following:

- 23 1. Plaintiff’s counsel submitted a written itemization of damages and settlement
