23 The parties agree that Plaintiff is entitled to an award of attorney’s fees and expenses to be
24 paid by the Defendant, pursuant to the Equal Access to Justice Act (EAJA), 28 U.S.C. § 2412(d),
25 subject to any offset as described in *Astrue v. Ratliff*, 130 S. Ct. 2521 (2010).

26 The parties agree that an award of attorney’s fees in the amount of \$6,250.00, and expenses
27 in the amount of \$14.31, for a total of \$6,264.31, shall be awarded to Plaintiff as a settlement
28 amount.

If it is determined that Plaintiff’s EAJA fees and expenses are not subject to any offset
allowed under the Department of the Treasury’s Offset Program, then the check for EAJA fees and
costs shall be made payable to **Kelsey Mackenzie Brown**, based upon Plaintiff’s assignment of
these amounts to Plaintiff’s attorney.
