20	with prejudice. (Dkt. No. 22). Plaintiff filed a Second Amended Complaint on October 22, 2014, to

22	2014, because it was filed without a stipulation or leave from the Court. (Dkt. No. 24).

25	stipulate that Plaintiff be permitted to re-file the Second Amended Complaint (previously filed October			
26	22, 2014). See Fed. R. Civ. P. 15(a)(2). The parties further stipulate that such Second Amended			
27	Complaint shall be filed on or before November 7, 2014, and that any responsive pleading be filed on			

28 or before November 21, 2014. *See* Fed. R. Civ. P. 15(a)(3).
