| 21 | In his original complaint, Plaintiff alleged violations against correctional officers and             |  |
| 22 | medical staff at Folsom State Prison and California Correctional Institution. The events took         |  |
| 23 | place in Sacramento County, which is part of the Sacramento Division of the Eastern District of       |  |
| 24 | California, and in Kern County, which is part of the Fresno Division.                                 |  |
| 25 | On April 7, 2015, the Court screened Plaintiff's complaint and dismissed it with leave to             |  |

| 27 | Following an extension of time, on May 11, 2015, Plaintiff filed his first amended                    |  |
