ORDER OF TRANSFER


Petitioner is a state prisoner currently incarcerated at Pelican Bay State Prison. He has filed a pro se petition for a writ of habeas corpus under 28 U.S.C. § 2254 challenging his conviction in Merced County Superior Court. A petition for a writ of habeas corpus made by a person in custody under the judgment and sentence of a state court of a state which contains two or more federal judicial districts may be filed in either the district of confinement or the district of conviction. *See* 28 U.S.C. § 2241(d). Each of such districts shall have concurrent jurisdiction to entertain the petition; however, the district court for the district where the petition is filed may transfer the petition to the other district in the furtherance of justice. *Id.* Federal courts in California traditionally have chosen to hear petitions challenging a conviction or sentence in the district of conviction. *Dannenbergh v. Ingle*, 831 F. Supp. 767, 768 (N.D. Cal. 1993); *Laue v. Nelson*, 279 F. Supp. 265, 266 (N.D. Cal. 1968).

Merced County lies within the venue of the Eastern District of California. *See* 28

1 U.S.C. § 84. Accordingly, this action is TRANSFERRED to the United States District
2 Court for the Eastern District of California. Ruling on the pending application for leave
3 to proceed in forma pauperis (docket number 2) is deferred to the Eastern District in light
4 of this transfer. The Clerk of the Court shall transfer this matter forthwith.

5 IT IS SO ORDERED.
