19 WHEREAS, Plaintiff Natividad Gutierrez (“Plaintiff”) filed a Notice of Settlement of
20 this action on February 10, 2015 (Dkt. 27);

21 WHEREAS, in his Notice of Settlement, Plaintiff requested until March 12, 2015 to
22 afford the parties time to complete settlement, which date the Court adopted in its Minute Order
23 as the last date to file dispositional documents (Dkt. 28);

24 WHEREAS, as a condition precedent to filing a stipulation for dismissal of prejudice of
25 the action pursuant to the terms of the settlement agreement, the settlement payment was to be
26 received by Plaintiff from Defendants Manuel Nunez, Aracely Nunez, and Avtar Kaur Sohal
27 dba J-R Market (“Defendants,” and together with Plaintiff, “the Parties”) on March 2, 2015;
28 however, such settlement payment has not yet been received;

1 WHEREAS, Defendants anticipate making the settlement payment promptly such that it
2 is received by Plaintiff no later than March 25, 2015;

3 NOW, THEREFORE, the Parties hereby respectfully request that the time within which
4 dispositional documents must be filed be extended to March 26, 2015.
