THE PARTIES, BY AND THROUGH THEIR RESPECTIVE ATTORNEYS OF
 RECORD, hereby stipulate as follows:

1. YI MAK was served with the Complaint in the above-captioned matter on
 August 27, 2014. Accordingly, the original deadline for YI MAK to file a responsive pleading
 pursuant to Fed. R. Civ. Proc. 12 (a)(1)(A) is September 17, 2014.

2. The parties have agreed to a 15-day extension for YI MAK to file his
 responsive pleading(s). The deadline is therefore extended to October 2, 2014.
