| 18 | Plaintiff is a state prisoner proceeding pro se and in forma pauperis in this civil | | |
| 19 | rights action brought pursuant to 42 U.S.C. § 1983. On September 29, 2014, Plaintiff's | | |
| 20 | complaint was dismissed for failure to state a claim, but he was given leave to file a first | | |

1 inherent power to control their dockets and "in the exercise of that power, they may 2 impose sanctions including, where appropriate . . . dismissal of a case." Thompson v. 3 Housing Auth., 782 F.2d 829, 831 (9th Cir. 1986). A court may dismiss an action, with 4 prejudice, based on a party's failure to prosecute, failure to obey a court order, or failure 5 to comply with local rules. See, e.g., Ghazali v. Moran, 46 F.3d 52, 53-54 (9th Cir. 1995) 6 (dismissal for noncompliance with local rule); Ferdik v. Bonzelet, 963 F.2d 1258, 1260-7 61 (9th Cir. 1992) (dismissal for failure to comply with an order requiring amendment of a 8 complaint); Carey v. King, 856 F.2d 1439, 1440-41 (9th Cir. 1988) (dismissal for failure 9 to comply with local rule requiring pro se plaintiffs to keep court apprised of address); 10 Malone v. U.S. Postal Service, 833 F.2d 128, 130 (9th Cir. 1987) (dismissal for failure to 11 comply with a court order); Henderson v. Duncan, 779 F.2d 1421, 1424 (9th Cir. 1986) 12 (dismissal for lack of prosecution and failure to comply with local rules).

In determining whether to dismiss an action for lack of prosecution, failure to obey
a court order, or failure to comply with local rules, the Court must consider several
factors: (1) the public's interest in expeditious resolution of litigation, (2) the Court's need
to manage its docket, (3) the risk of prejudice to the defendants, (4) the public policy
favoring disposition of cases on their merits, and (5) the availability of less drastic
alternatives. <u>Thompson</u>, 782 F.2d at 831; <u>Henderson</u>, 779 F.2d at 1423-24; <u>Malone</u>, 833
F.2d at 130; <u>Ferdik</u>, 963 F.2d at 1260-61; <u>Ghazali</u>, 46 F.3d at 53.

20 In the instant case, the public's interest in expeditiously resolving this litigation 21 and the Court's interest in managing its docket weigh in favor of dismissal. The third 22 factor, risk of prejudice to Defendants, also weighs in favor of dismissal, since a 23 presumption of injury arises from the occurrence of unreasonable delay in prosecuting 24 this action. Anderson v. Air West, 542 F.2d 522, 524 (9th Cir. 1976). The fourth factor --25 public policy favoring disposition of cases on their merits -- is greatly outweighed by the 26 factors in favor of dismissal discussed herein. Finally, as for the availability of lesser 27 sanctions, at this stage in the proceedings there is little available which would constitute 28 a satisfactory lesser sanction while preserving scarce Court resources. Plaintiff has not

paid the filing fee for this action and is likely unable to pay, making monetary sanctions
 of little use.
