26 **WHEREAS:**

- 27 1. Plaintiff Ronald Moore filed this action on August 29, 2014.
- 28 2. This is the second request for an extension of time for Defendants KANAWAL PREET SINGH, aka ANWALP SINGH, individually and dba STOP N SHOP LIQUOR #1 aka K & A LIQUOR and SURJIT SINGH, individually and dba STOP N SHOP LIQUOR #1 aka K & A LIQUOR (collectively referred to "Defendants"). A previous extension of time was granted by the plaintiff within the statutory allowance; thus, court approval is required for a further extension of time.
3. Plaintiff and Defendants are in settlement negotiations at this time.
4. Plaintiff has presented to Defendants a proposed settlement agreement for Defendants to review to settle this case. Additional time is needed by Defendants to determine feasibility.

1 5. The parties agree that settlement of this case would save valuable court time and resources.

2 6. The parties have agreed to extend Defendants' time to respond to the complaint until December  
3 3, 2014, subject to the court's approval, and believe that the case can be settled within that time.

4 7. This extension of time will not alter any date or event already set by Court order, including the  
5 mandatory scheduling conference.

6 NOW THEREFORE, Defendants through their attorneys, and Plaintiff Ronald Moore, through  
7 his attorneys, hereby stipulate and agree that the time for Defendants KANAWAL PREET SINGH,  
8 aka ANWALP SINGH, individually and dba STOP N SHOP LIQUOR #1 aka K & A LIQUOR nnd  
9 SURJIT SINGH, individually and dba STOP N SHOP LIQUOR #1 aka K & A LIQUOR to answer or  
10 otherwise respond to the Complaint shall be extended up to and including December 3, 2014, pending  
11 court approval.
