This is an immigration case currently held in abeyance pursuant to the Court's order of December 9, 2015. ECF No. 27. The government now advises the Immigration Judge terminated removal proceedings against Plaintiff William Douandju on April 28, 2016. United States Citizenship and Immigration Services (USCIS) has requested return of the alien file from Immigration and Customs Enforcement, and upon review of the file, anticipates requesting this Court for an order of remand pursuant to 8 U.S.C. § 1447(b), so that the agency can proceed with the adjudication of Plaintiff's naturalization application. USCIS requests a brief extension, until July 11, 2016, to review the file and assess the amount of time needed to complete adjudication of the naturalization application. On that date, USCIS will either file a motion for a remand
