1 Plaintiffs GENO GOMEZ and MARIA GOMEZ (“Plaintiffs”) and Defendant
2 NATIONSTAR MORTGAGE LLC (“Nationstar”), by and through their counsel of record, hereby
3 stipulate and agree as follows:

- 4 1. Whereas Plaintiffs filed their first amended complaint on April 2, 2015;
- 5 2. Whereas Nationstar’s response to the first amended complaint is due on April 20,
6 2015;
- 7 3. Whereas Plaintiffs and Nationstar entered into an initial stipulation to extend
8 Nationstar’s deadline to respond to the first amended complaint by 28 days;
- 9 4. Whereas, pursuant to Plaintiffs’ and Nationstar’s initial stipulation, Nationstar’s
10 response to the first amended complaint was due on May 18, 2015;
- 11 5. Whereas, Plaintiffs and Nationstar are continuing settlement discussions;

1 6. Whereas Plaintiffs and Nationstar agree that an additional 15-day extension of
2 Nationstar's deadline to respond to the first amended complaint will be beneficial for the purpose
3 of either settlement or determining that participating in a Court-ordered ADR program is the
4 appropriate way to proceed; and,

5 5. Whereas, Plaintiffs and Nationstar hereby stipulate that, upon approval of the
6 Court, Nationstar's response to the first amended complaint will be due on June 2, 2015.
