19 stipulate and agree as follows:

- 20 1. Whereas Plaintiffs filed their first amended complaint on April 2, 2015;
- 21 2. Whereas Nationstar's response to the first amended complaint is due on April 20,
22 2015;
- 23 3. Whereas Plaintiffs and Nationstar entered into an initial stipulation to extend
24 Nationstar's deadline to respond to the first amended complaint by 28 days;
- 25 4. Whereas, pursuant to Plaintiffs' and Nationstar's initial stipulation, Nationstar's
26 response to the first amended complaint was due on May 18, 2015;
- 27 5. Whereas, Plaintiffs and Nationstar are continuing settlement discussions;

2 Nationstar's deadline to respond to the first amended complaint will be beneficial for the purpose

6 Court, Nationstar's response to the first amended complaint will be due on June 2, 2015.
