1           Whereas, Plaintiff and the remaining Defendant THE WINE  
2 GROUP, INC., are currently involved in settlement discussions  
3 and have scheduled a mediation to take place on November 12,  
4 2015; and

5           Whereas, the parties wish to move back the dates for the  
6 exchanging expert witness information and completion of expert  
7 witness discovery to allow them to submit the Request for  
8 Dismissal of the UNION to the Court, and to complete settlement  
9 discussions between Plaintiff and THE WINE GROUP, INC.,  
10 including the mediation scheduled for November 12, 2015;

11           The parties through their counsel hereby agree and stipulate  
12 as follows:

13           1.     The deadline for the initial designation of experts  
14 shall be moved back from November 3, 2015, to December 2, 2015;

15           2.     The deadline for supplementing expert designations  
16 shall be moved back from November 19, 2015, to December 17,  
17 2015; and

18           3.     The deadline to complete expert witness discovery  
19 shall be moved back from December 2, 2015, to January 8, 2015.
