2 JENNA MCCAIN, and KYLE BARNETT, through their respective counsel, as follows:

3 **RECITALS**

4 1. The Scheduling Order in the above-entitled matter provides that initial expert
5 witness disclosures pursuant to Federal Rules of Civil Procedure, Rule 26(a)(2)(B) and (C) are to
6 completed by August 19, 2015.

7 2. The Scheduling Order further provides that any contradictory and/or rebuttal
8 experts authorized under Federal Rules of Civil Procedure, Rule 26(a)(2)(D)(ii) are to be
9 completed by September 18, 2015.


