On February 24, 2015, U.S. Citizenship and Immigration Services issued interview 18 notices pertaining to Plaintiffs' currently-pending naturalization applications. The interviews are 19 set for March 10, 2015. Plaintiffs have sought (among other relief) an order requiring 20 adjudication of their naturalization applications, and Defendants believe that the issuance of interview notices has the potential to affect this Court's jurisdiction over Plaintiffs' first two 22 causes of action, in that interviews would trigger the statutory 120-day deadline for issuance of 23 decisions on Plaintiff's naturalization applications. See 8 U.S.C. § 1447(b). Accordingly, the 24 parties therefore stipulate to hold this matter in abeyance, vacate the March 17, 2015 hearing 25 date, vacate the April 16, 2015 status conference, and instead file status reports or a joint status 26 report if possible by May 1, 2015. The parties agree that this stipulation itself has no effect on 27 Plaintiffs' right to seek, or Defendants' right to oppose, attorney's fees under the Equal Access to 28
