STIPULATION FOR DISMISSAL

Having entered into a Confidential Settlement Agreement dated April 6, 2015 (“Settlement Agreement”), Plaintiff and Counter-defendant Jinjiang Daxing (Diapenie) Textile Co. Ltd. and Defendant and Counter-claimant UV Skinz, Inc. hereby stipulate pursuant to Fed. R. Civ.
