20	U.S.C. § 405(g) and to Entry of Judgment (ECF No. 14), this matter shall be remanded to the

23	On remand, the Office of Disability Adjudication and Review's Appeal Council will

	and SSR 82-62, and, if appropriate, obtain supplemental vocational expert testimony to assist in		

1	determining what jobs exist, if any , for Plaintiff given her age, education, vocational factors, and	
2	residual functional capacity.
