The Court adopts the findings and recommendations, filed on February 11, 8 2015 (ECF No. 14), in full; 9 2. Plaintiff's complaint (ECF No. 1) is DISMISSED for failure to state a claim; The Clerk's Office is directed to send Plaintiff a habeas petition form; and 10 3. 11 4.
