11 WHEREAS:

- 12 1. Plaintiff Ronald Moore filed this action on March 2, 2015.
- 13 2. Plaintiff and Defendants are in settlement negotiations at this time and it appears
14 highly likely that a settlement is imminent, however, the CASp inspection and report needed to
15 finalize a settlement is not yet completed, and approximately three weeks will be needed to
16 finalize the settlement.
- 17 3. The initial scheduling conference in this action is currently set for June 9, 2015.
- 18 4. The Defendants' time to respond has previously been extended, with responses due
19 May 14, 2015 and May 31, 2015.
- 20 4. Parties agree that settlement of this case would save valuable court time and
21 resources and make the pending scheduling conference unnecessary. Further, preparation for the
22 scheduling conference will add to the costs of the case and make it more difficult to reach a
23 settlement.
- 24 5. In order to facilitate settlement, the parties propose that the time for filing of
25 defendants' responses be extended further to June 30, 2015 and that the initial scheduling
26 conference in this matter be continued to a date on or after July 15, 2015, at the Court's
27 convenience.

2 through his attorneys, hereby stipulate and agree that the new deadline for Defendants SVP
3 PARTNERS, LLC and QUICK 'N' E-Z, INC. dba QUICK N EZ FOOD 25 to file an answer or
4 otherwise respond to the complaint is June 30, 2015, and that the initial scheduling conference in
5 this matter shall be continued to a date on or after July 15, 2015 at the Court's convenience,
6 pending court approval.
