1           WHEREAS, the Court entered judgment following the second trial in this matter on  
2 December 13, 2021 (Dkt. 499);

3           WHEREAS, on February 4, 2022, pursuant to a stipulated request by the parties, the Court  
4 ordered, in relevant part, that “if a notice of appeal is filed by either party after resolution of GIS’s  
5 pending motion for a new trial and renewed motion for judgment as a matter of law (Doc. 502),  
6 the deadline to file bills of costs and motions for attorneys’ fees shall be stayed until ... 28 days  
7 after the appeal is fully resolved and a mandate is issued by the Ninth Circuit” (Dkt. 507);

8           WHEREAS, following GIS’s appeal, the Ninth Circuit affirmed the entry of judgment on  
9 July 3, 2023 (Dkt. 527), and issued its mandate on July 25, 2023 (Dkt. 528);

10          WHEREAS, the parties’ deadline the file bills of costs and motions for attorneys’ fees is  
11 currently August 22, 2023; and

12          WHEREAS, the parties wish to have additional time before the filing of motions to  
13 explore a potential resolution of this matter;

14          THEREFORE, the parties hereby stipulate and respectfully request that the Court extend  
15 their deadline to file bills of costs and motions for attorneys’ fees to **September 12, 2023**.
