Based upon the above stipulation, the Court HEREBY ORDERS that Defendants LOS BANOS UNIFIED SCHOOL DISTRICT, STEVE TIETJEN, RYAN HARTSOCH, DANIEL SUTTON, and VELI GURGEN are dismissed from this action with prejudice, each party to bear its own costs, expenses, and attorneys' fees. Furthermore, as all parties who have appeared in this action have signed the stipulation of dismissal, the case has ended. *See* Fed. R. Civ. P. 41(a)(1)(A)(ii); *Wilson v.
