 ADDITIONAL 60 DAY STAY OF
 LITIGATION**

Complaint Filed: April 10, 2015

19 WHEREAS the parties to this action previously stipulated to a 60 day stay of this action to
 20 explore resolving this matter informally;

21 WHEREAS the Court issued an order staying the action until September 1, 2015;

22 WHEREAS the parties are continuing to discuss resolving this matter informally and have
 23 exchanged documentation to allow them to evaluate their respective claims; and

24 WHEREAS, subject to the Court issuing an order consistent with the terms of this stipulation,
 25 the parties, by and between their respective attorneys, stipulate as follows:

- 26 1. This action is stayed an additional 60 days to October 31, 2015;
- 27 2. If the matter has not resolved by October 31, 2015, defendant agrees to waive service

1 and file a responsive pleading by November 23, 2015;

2 3. All deadlines pursuant to Federal Rules of Civil Procedure 16, 26 and/or the Court's
3 local rules are continued to be reset following the expiration of the stay;

4 4. The parties will meet and file a Joint Scheduling Conference Statement no later than
5 December 2, 2015.
