19	Plaintiff is a prisoner proceeding pro se pursuant to 42 U.S.C. § 1983 and has requested		
20	leave to proceed in forma pauperis pursuant to 28 U.S.C. § 1915. Plaintiff has made the showing		
21	required by § 1915(a) and accordingly, the request to proceed in forma pauperis will be granted.		
22	Plaintiff is obligated to pay the statutory filing fee of \$350.00 for this action. 28 U.S.C.		
23	§ 1915(b)(1). Plaintiff is obligated to make monthly payments in the amount of twenty percent of		
24 25	the preceding month's income credited to plaintiff's trust account. The Saguaro Correctional		
25 26	Center is required to send to the Clerk of the	Court payments from plaintiff's account each time	
26 27	the amount in the account exceeds \$10.00, until the statutory filing fee is paid in full. 28 U.S.C.		
27	§ 1915(b)(2).

1	In accordance with the above and good cause appearing therefore, IT IS HEREBY	
2	ORDERED that:	
3		
4	1. Plaintiff's application to proceed in forma pauperis is GRANTED;	
5	2. The Warden of the Saguaro Correctional Center or his designee shall collect	
6	payments from plaintiff's prison trust account in an amount equal to twenty per cent	
7	(20%) of the preceding month's income credited to the prisoner's trust account and	
8	shall forward those payments to the Clerk of the Court each time the amount in the	
9	account exceeds \$10.00, in accordance with 28 U.S.C. § 1915(b)(2), until a total of	
10	\$350.00 has been collected and forwarded to the Clerk of the Court. The payments	
11	shall be clearly identified by the name and number assigned to this action.	
12	3. The Clerk of the Court is directed to serve a copy of this order and a copy of	
13	plaintiff's in forma pauperis application on the Saguaro Correctional Center, via U.S. mail	
14	at 1250 East Arica Road, Eloy, AZ 85131.	
15	4. The Clerk of the Court is directed to serve a copy of this order on the Financial	
16	Department, U.S. District Court, Eastern District of California, Sacramento Division.	
17	5. Within sixty (60) days of the date of service of this order, plaintiff shall submit a	
18	certified copy of his prison trust account statement for the six-month period immediately preceding the filing of the complaint, if plaintiff has not already done so.
